
Export industry

PROGRAMME STRUCTURE

The curriculum of the master programmes consists of specialisation and general subjects. This ensures a balance between knowledge and skills that is in line with the requirements of the modern business world. The general subjects, which focus on management, projects and research, provide a solid basis to build, to focus and go more in-depth into the specialisation subjects. The subjects are interactive and practical and challenges you to take an active role in the programme.

Throughout the year you will follow a personal leadership programme and work on an international project with students from the other master programmes. You will also have the opportunity to work with students from other universities on a sustainability related business challenge during the pressure-cooker week, which is integral part of the Managing Corporate Sustainability course. During the year you may join a number of field trips and company visits. This way you get a taste of the real world and you grow your network.

The Master programmes are accredited by the NVAO (Dutch-Flemish Accreditation Organisation)

LECTURERS

Our lecturers are a reflection of the international classroom. You will be taught by a multinational mix of experts in the field of supply chain management, finance and consultancy. Our lecturers have years of professional experience in multinationals and hold a Master's or Doctoral degree. This combination of academic knowledge and practical experience provides you with the benefit of seeing how theory is applied in practice.

STUDY LOAD

Our programmes consist of four study blocks. Each block consists of 10 weeks in which you will follow classes for eight weeks and take assessments in the last two weeks. The curriculum of the master programme consists of a coherent set of subjects, reflecting the profile of the study programme. If you have mastered the subject matter and you pass your exam/assignment, you will receive credits for this subject.

One credit reflects 28 hours of study per subject. The number of credits to be scored therefore depends on the number of lectures, the number of self-study hours and the time needed to prepare for the exams and assignments. The total study load (in credits) for the entire master programme is 60 credits.

Master in Finance and Accounting (MSc)

The goal of any enterprise is to create value for its stakeholders. Making the right financial decisions is essential for organisations to achieve the best possible results and to avoid unnecessary risks. The Master in Finance and Accounting enables you to build the knowledge and analytical skills you need to become a specialist in financial decision-making aimed at steering organisations to success.

THE PROGRAMME

During the programme you will learn how to collect and open up all relevant financial information that a business needs to succeed, how to communicate with your stakeholders and how to take the lead in the process. You will be taught how to improve a business's ability to withstand extreme or unforeseen events, allowing it to take advantage and respond confidently to unfolding opportunities. Finally, you will gain the skills to connect organisations, their data, people and processes.

YOUR FUTURE

Master in Finance and Accounting graduates perform successfully in fields such as:

- Translating external developments to internal business processes.
- Providing support for decisions about critical financial issues.
- Analysing the financial performance of the organisation as a whole and of individual business units.
- Implementing up-to-date cost systems and allocating decision rights.
- Developing a conceptual framework for providing accounting information to investors and creditors.

STEPS TO YOUR ENROLMENT

1. Apply & register for your master programme through [Studielink.nl](https://studielink.nl)
2. Send us the required certified documents via email for evaluation. Original documents in German or French are accepted. Documents in other languages need to be translated into English
3. We invite you for a Skype interview to talk about your motivation and answer any questions.
4. After a positive evaluation you will receive the conditional admission letter (and invoice). Your admission is finalised after we have received your original documents (payment & visa approved). After payment, we will apply for your student visa on your behalf. (only for non-EU/EEA nationalities)
5. Arrange your student housing and make your travel arrangements to come to the Netherlands. (for non-EU/EEA only after receiving the travel visa)
6. Introduction week: Supply us with your original documents and we will introduce you to the city and assist you with all required legal matters in Rotterdam.

INTAKE DEADLINES

September intake: non-EU: 1 May EU/EEA: 31 Jul

February intake: non-EU: 1 Nov EU/EEA: 1 Jan

STUDENT SUPPORT

The Centre of International Affairs can assist you with several non-programme related matters.

UNIVERSITY STUDENT HOUSING (by SSH)

PICK UP SERVICE

Pick-up service on arrival is provided to all international students arriving at Amsterdam Schiphol airport.

INSURANCE

By Dutch law all citizens of the Netherlands must be insured. For Non-EU applicants, this is also a requirement to obtain the student visa. EU-applicants need to check if their insurance also covers studying in the Netherlands. Student insurance includes: healthcare, liability, legal aid and household goods.

VISA/RESIDENCE PERMIT (non-EU/EEA only)
